Detailed rules for Re-evaluation of Answer Books are reproduced below:

1. They can download the prescribed Application Form from the Website : [www.jodhpurnationaluniversity.com](http://www.jodhpurnationaluniversity.com)
2. Re-evaluation can be sought in not more than 50% of the theory papers in which the student appeared at the examination or in which the examination was conducted by the University.
3. The candidate shall be required to pay a fee of Rs. 500/- per paper (not subject) for the re-evaluation of answer books, which will not be refunded.
4. It is notified that re-evaluation means fresh assessment of the questions attempted by them during the examination and not merely re-totaling of the marks secured by the student.
5. It is also notified that the marks already secured by them will not be reduced.
6. The candidate shall submit his original marks sheet to the University along with the Application Form, failing which the application form will not be entertained.
7. The application forms submitted after last date will not be entertained .
